Issue of Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the **"Company")** advises that it has issued and allotted 500,000 fully paid ordinary shares ("**Shares**") upon the exercise of 500,000 unquoted options exercisable at \$0.10 per option on or before 6 April 2022.
