Issue of Shares - Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

Los Cerros Limited (ASX: LCL) ("Los Cerros" or the "Company") advises that it has issued and allotted 637,500 fully paid ordinary shares ("Shares") upon the exercise of 637,500 unquoted options exercisable at \$0.02 per option on or before 18 May 2022.
